ARBITRATION

Niels Grubbe has been the chairman of a considerable number of national and international arbitral tribunals established by the Danish Building and Construction Arbitration Board, by the Danish Arbitration Institute, The International Court of Arbitration (ICC), and on an ad hoc basis (nominated by the parties acting jointly). In addition, he has been a teacher at the Bar Association's Arbitrator Education.

INTERNATIONAL EXPERIENCE

From 1992 to 2000 Mr. Niels Grubbe as an attorney-at-law has undertaken several projects in Russia acting either as the attorney of private enterprises or of the State of Denmark, especially concerning construction and building activities in Moscow and Saint Petersburg, and agricultural plants to the north of Saint Petersburg. The tasks have comprised the investigation of Russian law, the establishment of companies, negotiation of treaties, and negotiation and drawing up of contracts between Danish and Russian public authorities and private parties. He has also engaged in similar projects in White Russia and Lithuania.

In the 1990'ies Mr. Niels Grubbe has taught judicial ethics to judges in Lithuania on behalf of the Central Eastern European Legal Initiative (CEELI) – an American charitable organization that extends legal assistance to countries in Eastern Europe and the former Soviet Union in connection with preparation of parliamentary acts, education and training, practical cooperation etc.

From 2007 till now Mr. Niels Grubbe has been involved in the activities of the European Network of Councils for the Judiciary (ENCJ), including being a member of its Steering Committee 2007-10. He has been the chairman for working groups and editor/cowriter of reports on Quality management (2007-09), Quality Management and its relation to Transparency and Access to Justice (2008-09), Quality and Access to Justice (2009-10) and Quality and Timelines (2010-11). Furthermore, he has been the coordinator for ENCJ Regional Seminars on Timeliness (2013-16) in Warsaw, London, Bucharest and Madrid.

In 2007 Mr. Niels Grubbe has taught judges in Vietnam on the subject of arbitration in a business sector programme, "Commercial Dispute Resolution", for Danida.

TEACHING

In addition to being an associate professor of company law at the University of Copenhagen Mr. Niels Grubbe has been the coordinator and teacher at about 250 educational courses from 1975 to 2000 for the Lawyers Society, the Bar Association, the Certified Public Accountants' Association, the Danish Real Estate Agents' Association and others on subjects comprising company law, rental law and cooperative housing law.
